- Crossed out work should be marked UNLESS the candidate has replaced it with an alternative response.



2(g)	<p style="text-align: center;"><b>A02 (3 marks)/A03 (3 marks)/A04 (3 marks)</b></p> <p><b>A02 and A03</b></p> <ul style="list-style-type: none"> <li>• Taxation can be imposed on activities that damage the environment</li> <li>• Taxation is used to ensure consumers and producers pay the full social cost of producing a good or service</li> <li>• Increasing taxation from 7% to 19% would substantially increase the price of meat for consumers which may result in less demand for meat products</li> <li>• This would reduce the amount of greenhouse gas emissions caused by animals</li> <li>• Increased taxation could also raise additional revenue for the German Government</li> <li>• This could be used to finance other pollution reduction schemes or improve animal welfare</li> <li>• Taxation provides a market incentive for firms and consumers to switch to meat alternatives which may not cause as much environmental damage</li> </ul> <p><b>A04</b></p> <ul style="list-style-type: none"> <li>• However, increasing taxes on meat may reduce incomes for farmers if demand falls for meat products</li> <li>• Increasing taxes on meat products may reduce the choice for consumers of what food they can afford, particularly low-income families</li> <li>• Demand for meat may be quite inelastic and an increase in tax may do little to reduce demand and therefore only marginally reduce the amount of pollution</li> <li>• There are other methods that might be more effective in protecting the environment, such as subsidies, fines or pollution permits</li> <li>• The German Government should use a combination of methods to protect the environment</li> </ul>

3(e)	<p style="text-align: center;"><b>AO2 (3 marks)/AO3 (3 marks)/AO4 (3 marks)</b></p> <p><b>AO2 and AO3</b></p> <ul style="list-style-type: none"> <li>• Economic growth is the increase in the level of output by a nation and is one of the main macroeconomic objectives</li> <li>• Turkmenistan has seen a 6.2% GDP growth rate which could result in an increase in employment levels in the oil and natural gas extraction industries</li> <li>• This is due to firms requiring more workers for production as the economy grows</li> <li>• Figure 4 shows an increase over time of GDP per capita which indicates that people have more income in Turkmenistan</li> <li>• Consumers might be able to purchase more goods and services thereby improving standards of living</li> <li>• Rapid economic growth could also help to reduce poverty in Turkmenistan particularly as over 50% of the labour force work in agriculture</li> </ul> <p><b>AO4</b></p> <ul style="list-style-type: none"> <li>• However, not all economic growth is good for an economy</li> <li>• If economic growth is too fast, the Turkmenistan economy may overheat</li> <li>• This could result in demand pull and cost push inflation</li> <li>• Economic growth could also result in more negative externalities such as pollution and waste</li> <li>• Turkmenistan relies heavily on the extraction of finite resources such as oil and gas which may cause a long-run depletion of natural resources</li> <li>• Rapid increases in GDP can lead to a higher level of inequality as the gains from growth may go to only a few people</li> </ul>
